FRC's Acceptable Use Policy, applicable state laws, and regulations of Framingham State College (not applicable to administrative files.) All files stored on a user's account will be deleted at the end of the semester. The account will be disabled at the end of the academic school year or upon leaving the college. ITS also reserves the right to delete or disable any accounts that may violate the Acceptable Use Policy.
